3. Approval of Agenda

- a. Psychological Science PhD proposal how to proceed?
 - The new materials for the proposal were not available for the committee to review before the February 1st meeting. The proposal will be discussed at the committee's next meeting on February 15, 2021
- b. 2nd major subcommittee report
 - i. The committee will hear the 2nd major subcommittee report at a future meeting

5. New Business

- a. GPC/CUP flow to EPC (program proposal review process)
 - i. B. Canfield met with Frankie McCormick, GPC chair, and Norma Froelich, Senate Chair, to discuss flow of proposals through the necessary reviewing bodies
 - ii. Proposed Process:
 - 1. Feb 1: New Program Pre-Proposal to EPC (all new programs should go through the pre-proposal process to ensure new resources are not required)

- 2. EPC makes recommendation to proposing department with GPC/CUP copied by end of semester (also informing senate)
- 3. Provost makes approval decision for moving forward
- 4. CUP/GPC receive full approved proposals in the fall
- 5. Final proposals are distributed to senate and EPC simultaneously as they exit GPC/CUP
- iii. Information Needed on Pre-Proposals:
 - 1. List/grid of courses including hours, teaching load, etc.
 - 2. Financial report from Matt Franti, Director of Budget & Finance
 - 3. Market Analysis
 - 4. Rationale for financial investment
 - 5. Best, worst, most likely financial/enrollment scenarios
 - 6. Plans for phase-out if program does not meet benchmarks
 - 7. Impacts/interactions of new program with current programs
- iv. Codify the pre-proposal/proposal process. Possible mediums include:
 - 1. The EPC webpage
 - 2. The Academic Affairs webpage
 - 3. University policy and procedures database
 - 4. EPC contractual language similar to departmental bylaws: "refer to the EPC guidelines for the pre-proposal/proposal process"
- v. Pre-proposal process & revitalizing Academic Program Review (APR)
 - 1. Concerns regarding the workload of EPC if pre-proposal process and APR are started at the same time
 - 2. APR could be reimagined to have reports due at the beginning of the fall semester
 - 3. New programs could be evaluated through a process similar to APR
- vi. B. Canfield will meet with GPC, CUP, and Senate Chairs to create a timeline/workflow for pre-proposals/proposals
 - 1. Recommendation that Finance be included in the discussion as well
- b. 5.1.1.1 ratio update
 - i. The committee will discuss the 5.1.1.1 ratio update at a future meeting
- c. APR subcommittee
 - i. B. Canfield noted that Provost Kerri Schuiling is in support of revitalizing APR for the fall
 2021 semester
 - ii. The committee will discuss the creation of an APR subcommittee at a future meeting
