Housing Requirement Information

The University's Housing Requirement is part of an effort to ensure optimum learning opportunities for students. The Requirement, which is a Condition of Enrollment, states that all single undergraduate students must live in a residence hall unless they:

1. Have reached junior status (56 or more hours of college credit) prior to registration for classes for the fall semester, or
2. Have resided four or more semesters in residence halls, or
3. Are twenty-one years of age or older on or before the last official day of registration for the fall semester, or
4. Are residing at home with their parent(s) or legal guardian(s), within 60 miles
5. Are veterans who qualify for veterans' benefits by virtue of at least one year of active service in the armed forces, or
6. Are taking eight or fewer credits during the semester in question.

Any student may apply for an exception to the housing requirement due to critical financial circumstances, serious medical reasons, or other extenuating circumstances which may prevent the student from complying with the University's Housing Requirement.

- a. Financial circumstances. A student who applies for financial reasons should have a Financial Aid Form (FAF) on file with the Financial Aid Office and have been in contact with that office to explore the possibility of obtaining additional support, or other alternatives available to him or her before applying for an exception to the housing requirement. The Financial Aid Office will normally be consulted in the process of evaluating the application.
- b. Medical circumstances. A student who wishes to apply for an exception to the housing requirement due to medical reasons must also obtain a Request for Medical Information form, which must be sent to his or her attending physician to document the circumstances to be considered. The completed Request for Medical Information form is then to be sent to the University's Health Center where it will be reviewed and commented upon with regard to on campus living by the University's physician.
- c. Other extenuating circumstances. A student who wishes to apply for an exception to the housing requirement for any other extenuating circumstance should include relevant documentation of the situation with his/her application.

Process For Requesting An Exception to the Housing Requirement

Applications for requesting an exception to the Housing Requirement are normally obtained at the Housing and Residence Life Office. Those applications will be acted upon by the Director of Housing and Residence Life or his or her designee. Appeals for denials to requests for exceptions to the Housing Requirement, in cases where the procedure has been followed correctly, may be submitted in written form to the Director of Housing and Residence Life within 10 class days of the date that the decision was mailed or handed to the student for referral to the Housing Appeals Committee. The membership of the Housing Appeals Committee will consist of the Assistant Director of Housing and Residence Life who will serve as the non-voting chairperson, two staff or faculty members appointed by the Associate Provost for Student Services and Enrollment, and one student recommended by the Residence Hall Presidents' Roundtable. The decision of the Housing Appeals Committee is final.
